6.1 The rates finalized for the routes coming under BIENNIAL RATE CONTRACT are fixed for the validity of contract. Except price variation clause No.16.3 of the terms and conditions of the contract.

7.0 EARNEST MONEY DEPOSIT (EMD)

- 7.1 The tenderer shall furnish as part of the tender, the EMD as specified for each route schedule for transportation of Raw Milk from different DCS to Main Dairy Dharwad / respective Chilling Centers in respective routes mentioned in tender through any of the following online modes of e-payment as mentioned in e-procurement portal.
 - i) Credit Card
 - ii) Direct Debit (Axis Bank Account holders)
 - iii) National Electronic Fund Transfer (NEFT) / Real Time Gross Settlement (RTGS)
 - iv) Over-the-Counter (OTC) remittance at Axis Bank designated branches

- 7.2 The EMD is to protect the DAMUL against risk of tenderers conduct which would warrant the security and forfeiture.
- 7.3 Any tender not secured as above, shall be treated as non-responsive.
- 7.4 Un-successful tenderers EMD shall be discharged as promptly as possible but not later than 45 days after expiration of tender validity.
- 7.5 Sucessful tender's EMD shall be discharge after the tenderer executing the contract agreement, and furnishing of the performance security (Security Deposit)
- 7.6 The EMD may be forfeited and tenderer will be black listed.
 - a. If the tenderer withdraw the tender before opening of Commercial tender for any reasons.
 - b. If the tenderer withdraws his tender during the period of tender validity specified by DAMUL

OR

- c. In case of successful tenderer, if the tenderer fails to
 - i. Execute the contract agreement.
 - ii. Furnish the Security Deposit
- 7.7 No earlier EMD or SD if any, are transferable against present tender, therefore, submission of 2 fresh EMD along with tender is mandatory.
- 7.8 EMD or Security Deposit shall not carry any interest.

8.0 PERIOD OF VALIDITY OF TENDER:

- 8.1 The tenders shall have validity of 90 days after opening of tender.
- 8.2 In exceptional circumstance the DAMUL may solicit the Tenderer's consent to extend the validity.

9.0 SIGNING OF THE TENDER DOCUMENTS:

9.1 As per e-procurement portal.

10.0 SUBMISSION OF TENDERS:

- 10.1 The prescribed EMD, relevant documents and technical and commercial documents shall be uploaded as per e-procurement portal only.
- 10.2 The tenderer should submit tender separately for each route if the tenderer is submitting tender for more than one route.

11.0 DEADLINE FOR SUBMISSION TENDERS:

- 11.1 Tenders must be uploaded by the tenderer as per the time and date specified in the invitation for tender through e-procurement portal. The DAMUL will not be held responsible for the website problems if any, last date submission or non-receipt of the same.
- 11.2 The DAMUL may, at is discretion, extend this deadline for submission of tenders by amending the tender documents in accordance with ITT clause 5, in which case all rights and obligations of the DAMUL and tenderers previously subject to the deadline will thereafter be subject to the deadline as extended.
- 11.3 Telephonic\ FAX \ E-mail tender's shall **not** be considered.
- 11.4 Tenderer shall not be permitted to change/modify the tenders subsequent to deadline for submission of tenders.
- 11.5 Tenderer shall not be allowed to withdraw the tenders between the deadline for submission of tender and expire of the period of tender validity. Withdrawal of a tender during this period would result in forfeiture of tender EMD and blacklisting of the tenderer.

11.6 Technical tender found responsive in all respect shall be Considered the commercial tender for opening.

13.0 OPENING OF TENDERS

- 13.1 The Technical Tender shall be opened on the date \ Time specified in the tender at DMU Campus.
- 13.2 The tenderers representatives who are present at the time of opening of tenders shall sign the register evidencing their attendance.
- 13.3 Technical tender, wherein, the tenderer BIO-DATA, based on various factors and eligibility of the Tenderer will be evaluated, considered and decided prior to opening and consideration of commercial tender of the tender.
- 13.4 The COMMERCIAL TENDER of the tenderers who do not satisfy any \ all the terms and conditions specifically so mentioned under Technical tender shall not be considered eligible and shall not be opened.
- 13.5 The date for opening if Price-quote shall be intimated to the qualified tender \ by letter \ Fax \ Telegram.
- 13.6 Commercial Bid, wherein the rates tendered by those who qualify themselves for and are selected as per the terms and conditions prescribed in Technical tender only will be considered and decided for the award of the contract for the route tendered on the basis of the rates quoted / finalized.

14.0 EXAMINATION OF TENDERS.

- 14.1 Tender shall be examined to determine whether they are complete.
- 14.2 The COMMERCIAL TENDER of the tenderers who do not satisfy any / all the terms and conditions specifically so mentioned under Technical Tender shall not be considered.
- 14.3 In the commercial Tender while indicating the price the same to be recorded clearly in figure as well as in words.
- 14.4 If there is any discrepancy between words and figures the lowest amoung the two shall be considered and same should be final.
 - 15.0 EVALUATION OF TENDER.
- 15.1 Taking into consideration Technical competence and the quoted price for the Route, the tenders shall be evaluated.
- 15.2 Not withstanding any thing contained in the tender schedule, no obligation is cast on DAMUL to accept the lowest tender and the union shall also reserves the right to accept or reject any or all the tenders without assigning any reason.

16.0 CRITERIA FOR AWARD OF CONTRACT:

- 16.1 The DAMUL shall award the contract to the tenderer whose tender has been determined to be substantially responsive to the tendering documents and who has offered the lowest evaluated price, provided further that the tenderer has the capability and the resources to carry out the contract effectively.
- 16.2 If any lowest Rate quoted tenderer for any reason fails to perform the contract, the concerned contractor shall be black listed and shall not be allowed to participate in any of the subsequent tenders.

16.3 Any variation in transportation charges for hike / reduction in fuel price the revised rates will come into effect from the date of opening of technical tender / negotiations and thereafter.

17.0 DAMUL'S RIGHTS:

17.1 DAMUL reserves the right to accept or reject any or all offers and to BRC the tendering process at any time prior to award of contract without thereby incurring any liability to the effected tenderer or tenderers or any obligatory to inform the effected tenders on the grounds of DAMUL action.

18.0 NOTIFICATION OF AWARD:

- 18.1 Prior to expiration of the validity of the tender the DAMUL may notify the successful tenderers in writing by Regd. Post that its tender has been accepted.
- 18.2 Notification of award shall constitute the formation of the contract.
- 18.3 Upon the furnishing by the successful tenderer of performance security and the agreement in accordance with clause, DAMUL discharge the EMD of Unsuccessful tenders.
- 18.4 The contractor should furnish Registration Certificate (See Regulation 2.1.1(5)) under FSS Act-2006 at the time completion of tender formalities.

SCOPE OF WORK FOR BIENNIAL RATE VEHICLE CONTRACT TO TRANSPORT MILK IN PROCUMENT ROUTES.

The contractor hereby undertakes to carry on the transport work for a period of TWO YEARS from the date of commencement of transport work specified in the final order issued by DAMUL or for such shorter period as may be determined by the DAMUL at its discretion and without assigning any reasons whatsoever.

The DAMUL ., may at its discretion and without assigning any reasons suspend for any length of time and from time to time the transport work in some of or in all milk producers societies in the contract route.

- A. The DAMUL may at any time during the validity period of this contract, revoke the suspension of the Transport work in some of or all the Milk Producer's societies in the contract Route.
- B. The contractors shall from the date specified by DAMUL., resume the transport work in some of or in all the Milk Producers Societies as may be specified by DAMUL., at the contractual Rate.
- C. The contractor shall not be paid any compensation of the transport work.
- D. The extension / suspension / terminate of contract shall be at the sole discretion of Managing Director and shall be without assigning any reason whatsoever it may be.

After the expiry of the validity period of this agreement the DAMUL may at its discretion extend the said validity period by three months or by such shorter or longer period/periods as may be necessary to enter into new agreements by calling for fresh tenders.

The contractor shall ply the vehicles owned by him and shall produce the vehicles with the registration certificates, tax paid receipts, comprehensive Insurance certificates and all the relevant documents in original before the Managing Director, DAMUL., or his nominee DAMUL before entering into agreement for the vehicles and road worthiness of the vehicles which is in the opinion of the authorities of the DAMUL., are not for the purpose of transporting the Milk as agreed to.

The contractor shall ensure that the contract vehicle shall meet the requirements \ specifications mentioned hereunder.

- a) The contract route vehicle shall be a closed type vehicle
- b) Have light points to be sufficiently illuminate the floor area for facilitating loading and unloading operations during night.
- d) Have stable and strong rear door.
- e) Have a seat for the van shroff of DAMUL., in the rear portion of the contract vehicle, and
- f) Be in road worthy clean and hygienic conditions

The contractor shall make his own arrangements for engaging the workers required for loading and un-loading and transport operations and further agrees to abide by the provisions of the contract labour (Regulation and Abolition). Act, in the matter of payment of their wages etc., and further indemnify the DAMUL., against any claim by such workers.

The contractor here by agrees that the labour so employed by him will be paid wages as per the minimum wages act if any inforce and further indemnifies and DAMUL., against any claim which those workers might have against contractors in respect of any claim under the workmen compensation Act or under any other statue.

The Contractor further agrees that the vehicle which he intends to employee for the purpose of contract, vehicle shall satisfy all the requirements to be specified by the authorities of the DAMUL., The contractor hereby agree to abide by and to carry out the instructions issued by the authorities of the DAMUL., with regard to the collection of the milk, the number of times shall be collected in a day, the time by which it should be collected from various points and the time at which the milk so collected shall be delivered to the Dairy \ Chilling centre \ farm coolers and further undertakes to abide by the various instructions issued by the DAMUL authorities with regard to the way in which he \ she should maintain the records relating to the collection as well as delivery of the milk which he \ she has collected as.

The contractor further agrees to ensure that the vehicles shall reach the milk collection centre on the contract route at least 15 minutes before the specified time and it is further agreed that the time is the essence of the contract and in case the vehicle of the contract fails to reach the collection point 15 minutes before the specified time agreed that the DAMUL., will be at liberty to make alternative arrangements for transportation of the milk and contractor shall be liable to make good loss or damage which the DAMUL., may suffer on the account. It is further agreed that in the event of the contractor committing default of this clause. The DAMUL., is at liberty to terminate the contract and in such an event the contractor is liable to pay the damage suffered by the DAMUL., in making alternative agreements.

It is further agreed that in addition to the transportation of the milk the DAMUL ., may require the contractor to transport commodities such as milk testing equipments chemicals testers and any other items from one place to another on the contract route at the rate specified for the transportation of milk and the contractor is not entitled to claim any extra amount for the transportation of such commodities including loading and unloading charges.

The contractor shall strictly confirm to the various instructions to be given from time to time by authorities of the DAMUL ., with regard to the safe transportation of the milk as agreed to under this contract.

It is further agreed that it is totally within the discretion of the DAMUL., to alter the points of collection as well as the routes and the points of delivery and the contractor is not entitled to claim any damages on account of such cancellation of the specified points or addition to any other point on the contract route or change of the contract route.

It is further agreed that contractor shall be responsible for the prompt substitution of vehicles in case of any break down, under intimation to concerned authorities.

- . The contractor further agreed that in addition to his workmen he shall allow the staff authorized representative of DAMUL., including the officials of the Milk Producers Co-Operative Societies Union to entrusted to him by the authorities of DAMUL., in vehicles that are permitted to be used in the respect of this contract.
- The contractor will not have the right to award such contract in any other person. However, the union reserves the right to transfer the contract in any other person on request of the contractor, such requisition should be made at least one month in advance from the date for which transfer is sought. The transfer of contract will be permitted only after three months from the date of contract. The original contractor should pay the transfer fee of Rs.5000-00 if the transfer is sought before six months and Rs.2500-00 after six months from the date of contract. The DAMUL., reserve the right either to accept or reject the transfer.
- The union has the sole authority to allot additional societies. Reduce the number of societies and to make necessary alternation in a particular milk route from time to time and the contractor will be informed by the union at the earliest of the change occurred due to these alterations, Union will pay the contractor for additional kilometer or deduct from the total amount for the deduction in KMS. However the total amount so deducted will not exceed 10% of the kms tendered / sanctioned. If it exceeds more than 10% of the tendered kms the same will be compensated. Any difference in kms due to diversion of the original route for any reason will not be met by the union.
- It is further agreed that the distance of the route mentioned in the tender notification are provisional and approximate and shall form the basis for settling the bills of the transport contractor for the present and the contractor hereby agrees to accept the correct mileage as disclosed by the joint survey to be conducted by the representatives of the DAMUL and the contractor. It is further agreed that if any payment that has already been made is found to be excessive after the joint survey, the contractor is liable to repay the same to the DAMUL & in the event of the amount paid is less the DAMUL shall pay the difference of amount to the contractor.

It is further agreed that the transportation charges stipulated under this agreement are not subject to any variation except as provided here under for hike \ reduction in the price of fuel by the state \ central Govt. of India. The transport rates paid to the contractor shall be revised on pro-rate basis.

- If the contractor runs the vehicle other than the vehicle which he has applied for the tender in a particular route a fine of Rs.100/- (Rupees One hundred only) per day will be imposed. However the contractor is allowed to change the vehicle provided, the vehicle is registered in the contractor's name after taking approval from the DAMUL.
- If the contractor fails to run the vehicle which he has applied for the tender in a particular route, for a period of 6 months continuously a fine of Rs.100/- (One hundred only) will be imposed per day and if the contractor continues to do so even after 6 months will be terminated and blacklisted.
- . If any lowest rate quoted tenderer fails to perform any reason the concern contractor shall be black listed and will not be allowed to participate in any of the subsequent tenders.
 - If the contractor fails to carryout the transport work assigned to him under the contract or does not carry out the entire transport work or part there of as per the terms and conditions of his agreement, or commits any breach of the terms and conditions of this agreement the DAMUL., may without prejudice to its other rights under this contract.
 - i) Terminate the contract or any portion thereof and or
 - ii) Forfeit the security deposit in whole or to the extent necessary in cover the loss incurred by DAMUL and or.

- iii) The contract to pay such sum of money as may be required to cover the loss suffered by DAMUL and or.
- iv) Recover from the contractor such some of money as may be required to cover the extra expenditure incurred by DAMUL., or that it may incur for securing similar services from other agencies.

- It is further agreed that in the event of the vehicle contract breaking down or meeting with an accident or is rendered immobile by violent mobs striking workers whether belonging to the DAMUL or others the contractor may inform about the such development and further shall make immediate alternative arrangements to carry out the obligations under this contract.
- . The contractor hereby under takes to make good to DAMUL all consequential losses or damages due to souring of milk deterioration in the quality of milk etc., that DAMUL may incur owing the failure of the contractor to deliver the milk and other items at the specified time.
- It is further agreed that in the event of the points of collection become in accessible because of rains, floods, natural calamites, man made obstructions and the contract vehicle cannot go right up to the point of collection, the

contractor shall intimate about the same to the DCS concerned and further he shall make suitable arrangements at his own cost for taking delivery of the milk and the transporting the same to the dairy \ chilling centre in the event of the contractor committing default of this cause the contractor here by under takes to pay the head load charges has specified below by way of damages so that the DAMUL or the Milk Producers Co-Operative Societies can make alternative arrangements for lifting the milk from the point of collection to the point where the vehicle is parked. For this contractor should pay head load charges to the societies, The actual cost claimed by him for the said kms. incase of head load by DCS.

- It is agreed that in view of the fact the object of this agreement is to ensure that proper and prompt supply of milk and any dislocation of any such supply will impair the transportation of milk to the dairy \ Chilling centre \ Form cooler the contractor hereby agree to adhere to all the terms and conditions of this agreement.
- All disputes arising out of this contract shall be referred to MANAGING DIRECTOR, DAMUL who is the sole arbitrator and his decision shall be final.
- If any employee \ representative of contract is found pilfering and or adulterating and or destroying the milk and other item in trusted to the contract during the transportation or during loading and unloading operations at the premises of the Milk Producers Union \ Societies the contractor shall be responsible for loss and contractor shall make his good all such losses incurred by DCS from the day of default up to 45 days, DAMUL May at its discretion forfeit the security deposit and terminate the contract. If any employee or representative of the contractor misbehaves and or indulges in disorderly conduct with the stop of the Milk Producers Union \ Societies or with the members of the general public DAMUL may request the contractor to remove such un desirable person from the transport work. The contractor shall not re- employ such undesirable persons who has been removed from transport work either by the contractor him self or by any other contract engaged by DAMUL.

- The contractor shall be responsible to protect employee \ representative \ Agents engaged in connection with the transport work under this contract against fatal and non-fatal accidents arising from any cause whatsoever during the period of this contract or any extension thereto, and the contractor shall fully indemnify of the DAMUL against all or any claim for damage or injury to persons and property resulting from any such accident under the provisions of the workman compensation act or under any other enactment or statute or laws that may be inforce.
- All losses due to the acts of omission or commission of the contractor or his employees\ for representatives shall be borne by the contractor.
- The contractor shall not claim any compensation from DAMUL and for any damages that the contractor vehicle may suffer in an accident whether within the premises of the DAMUL / milk producers Union/ society or out side the said premises.
- The contractor shall not claim any compension for any damage that the contract vehicle may suffer in riots civil commotion strikes whether by the employees DAMUL or not farmers agitation where by the members to milk producers union / societies or not and whether within the premises of the DAMUL, Societies or outside the said premises.
- It is further to be understood that the transport work under this contract has as its objective maintenance of continuous and uninterrputed procurement of milk and milk producers societies in villages. The contractor herby undertakes to ply the contract vehicle on the contract route and carryout the transport work under his contract all conditions of whether and in the situation of law and order. In view of the event of the imposition of curfew and imposition of any restriction of the movement of vehicles and men by the military or the civilian authorities, DAMUL shall make every endeavor to obtain appropriate permission passes from the competent authorities for the movement of vehicle and personnel.
- The contractor shall ensure that the contract vehicle shall not while entering in to or moving in or going out of the premises of the DAMUL, societies cause any

loss or damage to DAMUL, to the building, plant and machinery or damages to societies. If any such loss or damages is causes to DAMUL, societies. If the contractor fails to make good the loss or damages caused to DAMUL, societies the DAMUL may recover the amount due from the bills of the contractor and take such other steps as may be necessary to recover the amount due from the contractor.

- The contractor shall ensure that the contract vehicle shall not while entering into to or moving in or going out of the premises of the DAMUL, Societies cause any injury to or the death of employees of DAMUL, societies or persons lawfully present at the premises of the DAMUL, societies. In the event of any injury to or death of employees of DAMUL, societies or persons lawfully present on the said premises the contractor shall reimburse to the DAMUL, societies the amount of compensation that the DAMUL, societies may be required to pay the workmen compensation Act any other enactment of statute law may be in force.
- The contractor hereby agree that he shall not assign the transport work under this contract or any portion thereof to any other person agency.
- The contractor shall provide to DAMUL, two passport size photographs of his staff and their names (i.e. Driver and loaders) for the purpose of issuing security passes before he runs the vehicle.
- The contractor should submit his\her final bill for payment along with NOC's of the concerned MPCS within one month from the completion of contract period.
- . The contractor shall furnish income tax clearance certificate before receiving final payment.
